Most meetings of public companies are available for the public to attend without being shareholders.

Questions to the Chairman and voting is only available to prior registered shareholders.

It is worth attending to support your Bank Warrior and BRN friends & colleagues even if you don't have, or can't buy shares. Check your super fund if you hold bank shares. Craig has found CommSec to be the cheapest online broker to buy or sell shares. From \$10 per trade. Minimum share purchase is \$500

You may be able to get a proxy to speak if you can't buy shares

It's always been a numbers game. BRN is aiming to have more members than all political parties combined. If you want an honest finance system and a representative democracy with polities accountable to you it's time to join in, become a warrior and get active.

It is worth noting that all the banks now have Model Litigant guidelines. This was an activist driven win. See Craig's third question in the video below as well as the BRN recommended Model Litigant principles.
